Certificate of Authority issued to **FIRST COMMERCIAL BANK**, Gideon, New Madrid County, Missouri, approving an increase in capital stock from \$250,500 consisting of 2,505 shares of common stock with a par value of \$100 per share to 269,300 consisting of 2,693 shares of common stock with a par value of \$100 per share. The increase was accomplished by the issuance of 188 additional shares of stock. Of the total proceeds from the sale of stock, \$18,800 will be placed in the Common Stock account and \$980,094.76 will be placed in Surplus. The additional capital is fully subscribed, paid up and in the hands of the Board of Directors.
