- August 3                   An application has been filed for approval of a plan of merger of **CHAMOIS INTERIM BANK**, Chamois, Osage County, Missouri, with and into **UNITED BANK OF CHAMOIS**, Chamois, Osage County, Missouri (the surviving bank), under the name of **UNITED BANK OF CHAMOIS**, pursuant to which the main banking house of the surviving bank shall be the present main banking house of **UNITED BANK OF CHAMOIS**, Chamois, Osage County, Missouri.
- August 6                   Application received from **FIRST BANK**, Creve Coeur, St. Louis County, Missouri, requesting permission to establish and maintain a separate branch at 6590 Lone Tree Way, Brentwood, Contra Costa County, California.

Certificate of Authority issued to **FARLEY STATE BANK**, Parkville, Platte County, Missouri, approving a change in location of the main banking house from 8807 N.W. 45 Highway, Parkville, Platte County, Missouri, to 6309 N.W. 9 Highway, Parkville, Platte County, Missouri.

Certificate of Authority issued to **FIRST COMMERCIAL BANK**, Gideon, New Madrid County, Missouri, approving an increase in capital stock from \$236,400 consisting of 2,364 shares of common stock with a par value of \$100 per share to \$250,500 consisting of 2,505 shares of common stock with a par value of \$100 per share. The increase was accomplished by the issuance of 141 additional shares of stock. Of the total proceeds from the sale of the stock, \$14,100 will be placed in the Common Stock account and \$697,374.72 will be placed in Surplus. The additional capital is fully subscribed, paid up and in the hands of the Board of Directors.
